It's A Wonderful Life Festival Vendor Rules & Regulations

1. Weather Policy - The It's A Wonderful Life Festival is a snow, cold, rain, or shine event. Please plan accordingly for inclement weather, including high winds. IAWLF is not responsible for any loss or damage to merchandise or displays.
2. Space Assignment - Each vendor will be assigned a space of approximately 10' x 10' located in the parking lot next to Chemung Canal Trust Company at 54 Fall Street.
3. Equipment & Power - Vendors must provide their own tables, chairs, and tent. Electricity is not available.
4. Cleanup - Vendors are responsible for removing all garbage and recyclables. If you bring it in, you take it out—including literature, cardboard, promotional items, and bagged trash.
5. Noise - The festival may provide music and entertainment during the day. Radios, megaphones, or loudspeakers are not permitted.
6. Refunds - Refunds for vendor space will be issued through November 28, 2025. No refunds will be issued after that date.
7. Parking - Vendor vehicles are not allowed on festival streets after 10:00 AM. Vehicles must be moved to off-street parking lots behind Fall Street businesses after unloading merchandise.
8. Special Equipment - Please indicate on your application if you plan to use a generator, helium, or anything beyond the merchandise listed. Generators require a fire extinguisher on-site.
9. Compliance - Vendors must comply with all local, state, and federal rules and regulations.
10. Vending Restrictions - Vending, solicitation, promotion, or distribution of merchandise, products, or information is not permitted outside of assigned vendor spaces without the express written permission of the It's A Wonderful Life Festival Committee.

Please be considerate of others around you. Use this information as a guide to ensure a safe, profitable and fun festival for all.
